# Tackling Epilepsy Deaths: MP Briefing



### **SUDEP Action**

Leader of PREVENT21 movement to tackle epilepsy-related deaths and lever potentially life-saving improvements to epilepsy services on the ground.

## **Epilepsy Deaths - Key Facts**

At least **21 epilepsy-related deaths a week** (9x riskier than asthma). Sudden Unexpected Death in Epilepsy (SUDEP) accounts for about 50% and other causes are accidents, suicide and prolonged convulsive seizures (Status Epilepticus)

Epilepsy is in top ten of all causes of mortality as many years of life lost as deaths in children & young

**3%** increase in people living and dying with epilepsy per annum. Death varies **3-fold** with deprivation (high prevalence and poor control means more deaths) - *Public Health England: Deaths from Neurological Conditions Report, 2018.* 

At least 42% of all epilepsy-related deaths avoidable. Epilepsy risk are often underestimated in decision-making between patients and health professionals, despite evidence that many can be reduced. There is wide variation in disclosing these potentially fatal risks to patients, with UK discussion rates varied from 4% - 80%. Epilepsy has no regular monitoring in contrast with asthma.

UK has 60,000 A&E attendances and 40,000 admissions due to epilepsy per year. Poor care was demonstrated by National Audit with 63% not seen in previous 12 months and 56% with no follow up.

#### Cost of epilepsy in the UK >£1Billion/year

Epilepsy is not yet included in the NHS 10-year plan – neither was it prioritised in the 5 Year Forward plan.

National research grant giving bodies in the UK have a poor track record on funding relevant research



## SUDEP Action's Prevent 21 Summit on Tackling Epilepsy Deaths

**71 delegates** representing **43 different organisations** participated in a collaborative two-day Summit to tackle deaths at Corpus Christi, Oxford November 2018. MPs participating included Paula Sherriff MP; Norman Lamb MP, Ed Vaizey MP and Ivan Lewis MP.

7 key recommendations were agreed by consensus at the Summit. These recommendations were underpinned by **recommendations from bereaved families** who have lost a loved on to Epilepsy:

Families bereaved by epilepsy have outlined the following recommendations as being important to the Bereaved Community:

- 1. Timely signposting of bereaved families to specialist support services and the Epilepsy Deaths Register after a death
- 2. The roll out of tools that accelerate putting guidelines into practice on conversations about risk
- 3. Increased research funding being made available and prioritised to support projects on epilepsy deaths and the implementation of interventions to support clinicians and people with epilepsy, & avoid future deaths
- 4. Neurological Conditions (specifically highlighting Epilepsy and Epilepsy deaths) to be included in the upcoming NHS 10-year plan

- A series of Parliamentary Questions tabled EG: Who is the Minister responsible for Epilepsy? Will Neurology / Epilepsy be prioritised in the upcoming NHS 10-year plan?

# Next Steps

- Letter to Health Select Committee asking for an inquiry into epilepsy-related deaths
- APPGE to seek/push for a meeting with Secretary of State for Health and Social Care
   To highlight the Summit recommendations & the need for Gov. to meet with the bereaved community
   and support those tackling epilepsy deaths.
- Epilepsy-related deaths to become a standing APPGE Agenda Item
   With SUDEP Action updating the APPGE on work relating to Epilepsy-related deaths at future APPGE meetings coordinating with other Epilepsy organisations, supportive MPs and APPGE Chair inbetween meetings to progress actions and achieve outcomes
